2. Target assortment short logs Pine (Pinus sylvestris)

QUALITY	B, C, B/C Sorting based on the currently valid RVR (Framework agreement for the raw timber trade in Germany)
ORDER LENGTH	5 m and 3 m
DELIVERY LENGTH	Order length + 0.10 m (min. 3.03 m / max. length 5.45 m)
DIMENSIONS	Minimum top diameter: 12 cm without bark Max. root collar: 60 cm without bark

3. Quality criteria of the sorting

QUALITY CLASS B

- Fresh, healthy, straight, without discoloration, measurable quality parameters (according to RVR)

QUALITY CLASS C

- Fresh, healthy, straight, measurable quality parameters (according to RVR)
- Slightly irregular curved curvature with low yield losses
- Superficial slight discolorations and slight injuries of the stem mantle are permissible
- Seasonal blue stain in fresh wood

QUALITY CLASS D

- Measurable quality parameters (according to RVR)
- Strongly irregular curved curvature with significant yield losses, but still suitable for sawing
- Blue stain due to overlay and red stripiness
- Bark-breeding insects, wood-breeding insects (< 2mm)

- Other relevant wood defects (wood still suitable for sawing): dents, knots, galls, cracks, etc.

QUALITY CLASS NFK (not suitable for sawing)

- Measurable quality parameters (according to RVR)
- Dimensionally and quality-related pulpwood (wood no longer suitable for sawing): Strongly irregular curved curvature, soft rot, heart over peeling damage, longhorn beetle and wood wasp infestation, severe cracks, etc

QUALITY CLASS A_SP (not suitable for sawing)

- Wood containing metal (splinter wood)

NOTES

- B/C contracts can be agreed (C share \leq 20%)
- Whole cuts shall be provided in principle
- A tree species- and length-sorted piling and supply is mandatory
- Please cut out the maximum possible proportion of 5 m short logs
- In individual cases, deviating agreements can be made in the contract
